NOTICE INVITING TENDER (NIT No. PHPA-I/SE(C&P)/146-08/2024)

Sealed item rate bids are hereby invited for and on behalf of Punatsangchhu-I Hydroelectric Project Authority (PHPA-I) from experienced and financially sound bidders from Bhutan (small W4) and India (**ISO Certificate**) firms fulfilling the eligibility criteria specified in the Bidding Document for the Work **Supplying and installation of CCTV Camera at Bjimthangkha colony, Dam Complex, Adit-I&II of HRT, O&M store, Pothead Yard and Power House of PHPA-I**

Eligibility Criteria

The participating Bidders shall fulfil the following criteria:

1. Have an average turnover of **Nu./Rs. 1.60 million or more** of any 3 years of the last 5 years preceding the last date of bid submission.
2. Have a valid registered relevant trade license for Bhutanese and Indian Bidders respectively.
3. Have the latest income tax/corporate tax clearance certificates. If such a clearance certificate is not being issued by the concerned authority, an authenticated photocopy of the latest income tax return shall be submitted by the Bidders.
4. Bidders should have experience in Design, Engineering, Supply, Erection, Testing and commissioning of Security Surveillance System (CCTV) in large instalments

OR

the bidder shall be authorized Dealer/Agent of the OEM and shall have letter of guarantee for OEM indicating their support for Design, Engineering, Manufacturing, Supply, Installation, Testing and commissioning of Security Surveillance System.

5. The bidder must have executed 1 (one) works of similar nature costing not less than **Nu./Rs. 1.60 million** OR 2(Two) similar works costing not less than Nu/Rs. 1.2 million OR 3(Three) similar works costing not less than Nu/Rs 0.8 million in the last 7 years and shall submit at least one completion certificate issued by the previous client(s) and its BOQ. Such certificate shall indicate the value, date, and site of works, and shall specify whether they were successfully completed.
6. Bidders shall submit evidence of access to or availability of a credit line of at least **Nu./Rs. 0.80 million or more** issued by the Banks or Financial Institutions in Bhutan/India.

The prospective Bidders may purchase the Bidding Document from the office of the Superintending Engineer (C&P), Bjimthangkha w.e.f 26.09.2024 to 25.10.2024 on payment of a non-refundable fee of Nu./Rs. 1,000 (one thousand) only in the form of a cash warrant or bank draft drawn in favor of PHPA-I, payable at the Bank of Bhutan (Wangdue) and state bank of India, Jaigaon.

The bidder can also download the Bidding Document from the PHPA-I website: www.phpa1.gov.bt at free of cost. Any corrigendum/addendum/errata in respect of this tender shall be made available only at the mentioned website. **The PHPA-I reserves the right to reject any or all the bids without assigning any reason thereof.**
